Discussion and vote to recommend to a Town Meeting the use of 2010/2011 budget surplus

First Selectman John Hodge spoke of the budget surplus and the need for a new plow truck and police car. Mr. Hodge spoke of various trucks and the equipment. The total surplus for the town for the 2010-2011 fiscal year is \$527,625. Approximately \$275,000 was previously approved to be spent on road repair leaving a balance of \$252,625. The BOS voted at their August 25th meeting to spend \$179,000 on Capital and Nonrecurring PW-Trucks and Equipment and Police Cars and Equipment. This must be approved by the BOF and at a Town Meeting that is scheduled for Thursday, September 8th.
