Update-State fiscal year 2017-2018 budget

Michael Cammarota noted that no budget has been passed yet for the State of Connecticut. It was decided to discuss this subject further once a budget is passed.

<u>Presentations/Discussions of Board of Education and Board of Selectmen plans for budget freezes, item deletions and project delays</u>

At the special meeting of August 30th, the BOF asked the Board of Education and the Board of Selectmen to come up with a contingency plan that includes optional operational freezes, budget line deletions and project delays of \$800,000 and \$300,000 respectively from their budgets. This is in response to possible state budget reductions.

Dr. Alicia Roy spoke of a plan approved by the BOE at their special meeting on September 5th. The plan mostly included delays to Capital Projects that included: High School/Middle School auditorium (\$155,000), Consolidated Water Storage project (\$45,000), Consolidated Parking Lot project (\$102,000), High School Family and Consumer Sciences project (\$278,000) and High School Locker Room Renovation (\$20,000). Dr. Roy spoke of how delaying these projects will affect the district. Cuts from salaries include not filling an open position for a High School Science teacher (\$93,199) and Unappropriated Salary funds or other remaining funds in the amount of \$106,801. Dr. Roy noted the BOE moved that this contingency plan is not binding and they reserve the right to revisit this plan once the state budget is approved.

First Selectman Susan Chapman noted that the BOS came up with the following contingency plan in the amount of \$300,000. The plan includes a 5% freeze of non-payroll items from certain departments which would amount to \$196,200 and the delaying of the following capital and nonrecurring project: Revaluation (\$44,800), Lake Studies (\$30,000), Fire Department-Airpack Upgrade/retrofit (\$24,000) and Recreation capital for the Beach House (\$5,000) for total for capital projects of \$103,800.

Cheryl Reedy thanked both the BOE and the BOS for their cooperation.

ONGOING UPDATES

Medical update- The year-end balance for 2016-2017 is approximately \$3.3 million.

Legal update- The available balance is currently \$104,853

<u>Year to date expenses review</u>- The Board reviewed expenses for the current fiscal year and noted that there were no concerns.

<u>Current year revenue update</u>-There was a revenue surplus of approximately \$112,000 for 2016-2017. This was due mostly to increased tax collections, increased Real Estate conveyance taxes and increased EMS revenues.

<u>Cap & Non review</u>- There was a brief discussion of a negative balance for Muskett Ridge and it was noted that this is money owed from the State.

Public Comment- None

<u>Future Agenda items</u>-The Board will discuss the State budget and the timeline and legal process for the contingency plan.

Tom Edwards made a motion to schedule a special BOF meeting on Wednesday, Oct. 4th at 7:30pm to discuss the State budget and ramifications. John Hodge seconded the motion.
