Notice is hereby given to the electors of the Town of New Fairfield and those qualified to vote at an Annual Town Meeting to be held on April 25, 2019 at 7:00 P.M. in the Community Room @ 33 Route 37 for the following purposes.

- 1. To consider and act upon the appropriation of Town Government Expenditures totaling \$12,516,732 from the General Fund, and \$762,306 from the Capital and Non-Recurring Fund, and \$849,757 from other Governmental Funds, as recommended by the Board of Finance, for the fiscal year commencing July 1, 2019 and ending June 30, 2020.
- 2. To consider and act upon the appropriation of Education Expenditures totaling \$42,949,443 from the General Fund, and \$398,369 from the Capital and Non-Recurring Fund, as recommended by the Board of Finance, for the fiscal year commencing July 1, 2019 and ending June 30, 2020.

Further notice is hereby given that the Board of Selectmen, acting pursuant to and in reliance on Section 7-7 of the Connecticut General Statutes, has removed Item #1 & #2 for submission to the voters by machine vote and shall be no earlier than seven (7) days, and no later than fourteen (14) days after April 25, 2019 and further provided that such time shall be no less than the hours of 12:00 Noon to 8:00 P.M.
