Chief Elected Officials,

At yesterday's HRRRA meeting it was discussed and approved to create a special HHW Fund using Hauler Registration Fees and additional revenue HRRRA will receive from the new regional waste contract.

**The motion was as follows: A Motion by J. Urice, second by F. Hurley, to support all Household Hazardous Waste event host communities (Bethel, Brookfield, Danbury, Newtown, New Milford and Ridgefield) with a \$10,000 subsidy. The funding to be provided through additional revenue received from the Regional Solid Waste and Recycling Agreement program fee and municipal registrations to be held by HRRRA that are approved by each Municipality.**

The purpose of this email is to request that each of you give me an **official confirmation to withhold your registration fees for the purpose** to create a special Household Hazardous Waste Fund to support the regional HHW events specifically to subsidize all host communities.

Below is a summary of the registration funds each town received for 2018-19 FY. I would estimate the fees will be about the same in 2019-20.
