Call To Order First Selectman John Hodge called the meeting to order at 7:30pm

Pledge of Allegiance

Correspondence and Announcements

First Selectman John Hodge spoke of the Gillotti Road project regarding the "rights of way" that was completed thirteen years ago. There has been a third and final audit by the state DOT and they are claiming that the Town is responsible for a percentage of charges that were never paid. First Selectman Hodge asked for a notice showing this liability.

First Selectman Hodge read a letter from Town Counsel John F. Keating stating that Mr. Keating is representing the town on the FOIC case on a pro-bono basis.

First Selectman Hodge read a letter that he sent to BOF member Lucy DiRocco regarding keeping order at BOF meetings.

Public Comment

Resident Tom Corbett spoke of the new three minute rule for public comment recently instated by the Board of Selectmen and also the million dollar budget surplus.

Approval of Minutes

Ron Oliveri made a motion to approve the minutes of the September 27, 2007 regular meeting as presented. Peggy Katkocin seconded the motion.

Water Pollution Control Authority update

Water Pollution Control Authority Chairman Tom Quigley announced that there will be a water testing day on Saturday, October 20th from 8am to 12noon at Shaw's. The cost for residents to test their water is \$40. Mr. Quigley also announced that there are currently two spots open for alternates on the WPCA.

Mr. Quigley spoke of the areas in town that use the town water system. This water system has been tested periodically. Mr. Quigley further spoke of repairs that were necessary for the town water system that were paid for out of the WPCA reserve fund. Mr. Quigley asked the BOS for a transfer to cover this repair.

The Board of Selectmen thanked Mr. Quigley for all his hard work with the WPCA.

Storage of voting machines

John Hodge made a motion to authorize the first selectman to sign the Certificate of Reimbursement for the storage of the voting machines. Ron Oliveri seconded the motion.

Update on New Fairfield Co. issue

Selectman Peggy Katkocin spoke about the MacBean subdivision in which some residents paid approximately \$200 each to have a survey done in order to make the subdivision legal. Many of these residents are now asking for the money paid to be reimbursed. A discussion ensued regarding how this situation could be handled. It was decided that First Selectman Hodge will send a letter to the residents asking them to send a letter to their Title Insurance Companies for reimbursement. If the insurance company does not pay then the town will consider reimbursement from town funds.

Traffic study at the entrance to New Fairfield High School

Ron Oliveri made a motion to authorize the first selectman to approach HVCEO regarding a traffic study at the entrance of New Fairfield High School. John Hodge seconded the motion.
