## Vote on proposed Selectmen's budget for 2008-2009

First Selectman John Hodge spoke of the Selectmen's recommended budget for 2008-2009. Mr. Hodge spoke of the Capital and Nonrecurring budget for 2008-2009.

John Hodge made a motion to approve the Board of Selectman's Operating budget for the fiscal year 2008-2009 in the amount of \$8,523,855 which represents a 4.80% increase over the 2007-2008 budget. Ron Oliveri seconded the motion.

First Selectman John Hodge gave an update on the new Senior Center. Based on the cost estimates, it appears that no additional funds will be needed for construction. A Public Hearing will be held in the near future concerning the Senior Center.
