Discussion of 2008-2009 BOS Budget

A lengthy discussion ensued among the members of the Board of Selectman in response to the Board of Finance decision of March 26th asking the BOS to come back to the BOF on April 2nd with proposed cuts of \$500,000. First Selectman Hodge spoke of specific cuts to the budget and the impact on the town. Some of these cuts are from the medical fund, some from the capital and nonrecurring fund and some from the operating budget. There was a discussion about using the Capital and Nonrecurring Fund to offset the Capital and Nonrecurring items in the budget. The BOF has thus far decided that they didn't want to use the Capital and Nonrecurring Fund.

There was also a discussion regarding having a vote of the concession stand and bathrooms at the turf field as a separate referendum item and let the people decide.
