Correspondence and Announcements

First Selectman John Hodge reminded residents that the budget vote will be held this Saturday, May 10th from 8am to 8pm at Meeting House Hill School.

Mr. Hodge announced that Candlewood Lake is up for sale again. Mr. Hodge spoke also about the Shoreline Management Plan.

Mr. Hodge spoke of a potential HART Commuter Bus service from New Fairfield to Southeast Train Station. Funding for this project will come from the NYDOT and CTDOT. A parking a lot is needed for this service and it is estimated that about forty parking spots will be needed. The upper parking lot at Memorial Field is a possibility for the parking lot. Mr. Hodge noted that he has met with Metro-North and MTA (Metropolitan Transportation Authority) and they may be willing to fund the parking lot expenses.

Presentation of Library plans

Library Board Chairman Sarah Marsh spoke of plans to make the library more ADA compliant. There is a referendum item on the budget referendum scheduled for May 10, 2008 asking the taxpayers for \$12,500 to do conceptual designs for the library. There may also be some state grants available. The deadline for these grants is August 29, 2008.

Presentation of Bathroom/Concession stand at Rebel Turf

Parks and Rec Director Steve Merullo and Parks and Rec Commission Chairman Ray Lubus spoke of plans for a bathroom/concession stand at Rebel Turf field at the High School. This item will be a referendum item on the budget referendum scheduled for May 10, 2008. Mr. Merullo showed plans for a two level building with storage on the bottom. The proposed building would be approximately 600 square feet and would easily tie in with the school septic system.

Historic Preservation Grant for Town Clerk

John Hodge made a motion to authorize the first selectman to sign an application for the town clerk to apply for a Historic Preservation Grant in the amount of \$7,000. Ron Oliveri seconded the motion.

Finance Director Jay Waterman spoke of shortfalls and excess of revenues and expenses for the 2007-2008 fiscal year. Mr. Waterman noted that interest income is down from last year, however not all revenues are in for the month of April. There was a comparison from this time last year. All three selectmen thanked Jay Waterman and the entire Finance Department for their hard work over the last year.

Adopt a Road

John Hodge read a letter from Debra Salvato requesting to be appointed as the entity for Bigelow Road for "Adopt a Road". Mr. Hodge thanked Miss Salvato for volunteering and encouraged other members of the community to volunteer. Anyone interesting in volunteering for the "Adopt a Road" program should contact the Selectman's office.

John Hodge made a motion to approve Debra Salvato to be appointed as the entity which will adopt Bigelow Road onto the "Adopt a Road" program for the Town of New Fairfield and to instruct the Public Works Department to mark Bigelow Road accordingly. Tom Corbett seconded the motion.
