First Selectman John Hodge announced that the town has been awarded a DECD grant in the amount of \$650,000 for the Senior Center. Construction on the Senior Center must begin by October 15, 2008. Mr. Hodge thanked fellow Selectmen Ron Oliveri and Tom Corbett as well as State Representative Jan Giegler, State Senator David Cappiello and State Representative Mary Ann Carson for all their work with this grant.

Selectman Ron Oliveri congratulated First Selectman John Hodge on all his work with this grant and also thanked fellow Selectman Tom Corbett.

Selectman Oliveri spoke of potential grant also in the amount of \$650,000 from a settlement from General Electric from pollution to the Housatonic River. This grant could potentially be used for hiking trails around New Fairfield. Mr. Oliveri thanked Tom Quigley, Ernest Fabrizio-Garcia, Bill McCann and Jeff Main for all their help with this project.
