First Selectman John Hodge presented Public Works Employees from the Town of New Fairfield with an award for special achievements. Mr. Hodge read a letter from Senior Business Agent for the Teamsters Warren Lucent congratulating the Public Works employees. Mr. Hodge introduced the employees and presented each one with an award.

Discussion of Dunham Pond Condominium issues

First Selectman John Hodge spoke of issues involving the Dunham Pond Condominiums. Mr. Hodge noted that he met with the developer on August 31, 2007 and was told the issues would be resolved within thirty days of that date. To date, these issues have not been resolved. The Planning Commission has also been meeting with the developer regarding fire safety issues at the complex. It was noted that two of the three fire safety tanks at Dunham Pond need to be replaced. John Hodge made a motion to authorize the first selectman to draw down on letters of credit numbered 10375 and 10376 established by Union Savings Bank in favor of the Town of New Fairfield for immediate fire safety repairs and improvements if the developer does not complete all work within the specified time limit as outlined in a document dated July 8, 2008 entitled "Sequence of Construction-completion of the woods at Dunham Pond Access Road" Specifically fire tanks and related repairs as listed under the fire safety section of the sequence of work shall be completed by July 28, 2008 and work on the Fire Access Road and the lower road as listed under the road construction directive session of the sequence of construction shall be completed within 30 days with proof of the signed contract between the developer and a licensed paving contractor submitted to the selectman's office within 14 days. The first selectman is hereby authorized to draw down on said letters of credit for fire safety reasons or any other developer related issues as verified by the town's land use counsel, without any further hearings or meetings. Ron Oliveri seconded the motion.
