To receive communication for the Board of Selectmen with respect to the resolution entitled "Resolution Appropriating \$2,000,000 for the purchase of an emergency communication system and authorizing the issuance of \$2,000,000 bonds of the town to meet said appropriation and pending the issuance thereof the making of temporary borrowings for such purposes." A special town meeting shall be adjourned for the purpose of voting on the foregoing resolution at an adjourned town meeting and referendum to be held between the hours of 12:00 noon and 8:00pm on Saturday, December 13, 2008 in accordance with the Connecticut General Statutes that the published as provided by law notice of special town meeting in the following form.

To consider the resolution entitled "Resolution Appropriating \$2,000,000 For The Purchase Of An Emergency Communication System And Authorizing The Issuance Of \$2,000,000 Bonds Of The Town To Meet Said Appropriation And Pending The Issuance Thereof The Making Of Temporary Borrowings For Such Purpose".

Copies of said proposed resolution are on file and open to public inspection at the office of the Town Clerk

Pursuant to Section 7-7 of the General Statutes of the State of Connecticut, as amended, notice is hereby given to the electors and persons qualified to vote at Town Meetings of the Town of New Fairfield that an adjourned Town Meeting and Referendum will be held at the Meeting House Hill School on Saturday, December 13, 2008 between the hours of 12:00 NOON and 8:00 P.M. for the purpose of voting on the following question:

"Shall the resolution entitled 'Resolution Appropriating \$2,000,000 for the Purchase Of an Emergency Communication System And Authorizing The Issuance Of \$2,000,000 Bonds Of The Town To Meet Said Appropriation And Pending the Issuance Thereof The Making Of Temporary Borrowings For Such Purpose' as introduced and read at a Special Town Meeting held December 3, 2008, be approved?"

The form of the ballot label for said question shall read as follows:

"Shall the resolution appropriating \$2,000,000 for the purchase of an emergency communication system and authorizing the issuance of \$2,000,000 bonds of the Town of New Fairfield to meet said appropriation, be approved? YES/NO". The voting will be by paper ballot/optical scanner. Those in favor of the resolution referred to in the question must mark the ballot in the space labeled "Yes". Those not in favor of the resolution referred to in the question must mark the ballot in the space labeled "No". Absentee Ballots will be available in the office of the Town Clerk as provided by law. The polls will be open during the hours between 12:00 NOON and 8:00P.M. Electors and persons qualified to vote as aforesaid will cast their votes at the Meeting House Hill School, New Fairfield, Ct.

The voting will take place pursuant to the provisions of the General Statutes, as amended, and the votes will be cast and canvassed and the results determined and certified as nearly as may be in accordance with the laws governing the election of Town officials. Tom Corbett seconded the motion.
