First Selectman John Hodge announced that Saturday, September 27th is the first annual soil testing day in New Fairfield from 8:30am to 2:00pm at Shaw's. Mr. Hodge noted that this test will determine if fertilization is necessary for the lawns. This test would be particularly helpful for residents that live around the lake.

Senior Center Update

Permanent Building Committee Chairman Al Mardis gave a presentation on the status of the proposed Senior Center. Mr. Mardis showed charts and went over the floor plan for the Senior Center. Mr. Mardis spoke of the advantages of modular construction and also the cost savings of owning a Senior Center instead of renting.

Bids for the Senior Center are expected back by October 7th and will be opened the same day at a PBC meeting on October 7th. The work for the Senior Center will begin by October 15th. Mr. Mardis encouraged members of the public to attend the PBC meetings.

First Selectman Hodge and Selectman Oliveri thanked Mr. Mardis for all his hard work in tying the project together and making sure that everything was done in a timely manner.

"New Fairfield Going Green" presentation by the Youth Commission

The New Fairfield Youth Commission made a presentation to the Board of Selectman regarding their successful project called "New Fairfield Going Green". The purpose of this project was to encourage New Fairfield residents to take care of the planet by recycling more and reducing energy consumption. A website was complied that allowed households to sign the pledge on line or on paper. Over 550 households in New Fairfield signed the pledge and the website was visited over 8000 times by users in 42 countries and 48 states. Selectman Oliveri noted that taxpayer dollars are not being used for this project but instead developer dollars that were posted before the project started and even legal representation is reimbursable.
