For the public roads the State Traffic Commission gave suggestions for speed limits and also noted the need for a lot more signs. The speed limits for the private roads were left to the discretion of the private communities and necessary signs would be at their expense.

John Hodge made a motion that the BOS as the legal traffic authority vote to endorse the speed limits as proposed in a document called "Traffic investigation report" from the State Traffic Commission dated May 2009 as presented by the State Traffic Commission. Tom Corbett seconded the motion.
