Call To Order First Selectman John Hodge called the meeting to order at 8:30pm

Correspondence and Announcements

First Selectman John Hodge announced that the HART commuter bus service will begin on Monday, May 18th. A schedule will be printed in the May 13th edition of the *Citizen News*. Mr. Hodge noted that the cost for the bus service is \$1.25 each way and a monthly pass will cost \$27. Anyone looking for more information can call the Selectman's office.

First Selectman John Hodge thanked his entire staff, the Health Department, the Board of Education, Superintendent of Schools Dr. Castagnola and his staff for the their thoroughness and completeness regarding the Swine Flu. Mr. Hodge noted that there were many meetings and that everyone cooperated. There was a pamphlet in the *Citizen News* last week giving suggestions for what to do in case of a pandemic. Mr. Hodge encouraged residents to read the pamphlet and to stock up on non-perishable items.

First Selectman John Hodge noted that he met with DEP along with State Representatives Mary Ann Carson, Jan Giegler and Mike McLachlan regarding Squantz Pond. DEP is promising that Squantz Pond will be staffed to the same level as last year and the State Police will also staff the outside of the park to the same level as last year.

Mr. Hodge noted that DEP kicked off the "Great Park Pursuit" at Squantz Pond this past Saturday.

First Selectman Hodge reminded residents that there will be a referendum vote this Saturday, May 16th from 8am to 8pm for the school and town budgets and the school building projects.
