First Selectman John Hodge announced that State Representative Mary Ann Carson along with State Representative Jan Giegler and State Senator Michael McLachlan had some legislation passed that required the DEP to look at the size of the boats on Candlewood Lake and see if there should be limitations for safety reasons. DEP recently put together a Candlewood Lake Boaters survey. This survey is available on the Town of New Fairfield website. First Selectman Hodge encouraged anyone with any interest in the lake to look at the survey.

First Selectman John Hodge announced that bids went out for the Musket Ridge Bridge replacement project. The bids came back significantly lower than expected. New Fairfield will pay for a percentage of this project. Construction will start once the State of Connecticut approves the bids.

First Selectman John Hodge noted that there are bids currently out for a federal stimulus project to repave the commuter parking lot at Company A Firehouse. This will be the first federal stimulus project in the Housatonic Region. First Selectman John Hodge thanked Public Works Director Bobby Rzasa for all his hard work with putting the package together for this project. It is hopeful that this project will start in the beginning of October.

First Selectman John Hodge spoke of a segment on Fox Business News that featured New Fairfield because of the recently attained AAA status. Mr. Hodge noted that it is hoping to get this on the website soon.
