Correspondence and Announcements

First Selectman John Hodge spoke of a Selectmen's meeting in December 2008 where the selectmen unanimously endorsed the radio project that was about to go to a referendum. Shortly thereafter, a complaint was filed with the State Elections Commission accusing the selectmen of misusing Channel 17 to express a particular view. Mr. Hodge noted that he just received notice that the entire complaint was dismissed by the State Elections Commission.

First Selectman Hodge spoke of a complaint to the Department of Economic and Community Development that the Senior Center was being misused and that proper tracking of the funding of the Senior Center was not done. DECD sent auditors to investigate and found absolutely no problems. This report is available in the Selectman's office if anyone would like to see it.

First Selectman Hodge noted that on Tuesday, October 13th the first federal stimulus package project in the area will start. This project is to create a commuter parking lot at Company A Firehouse.

First Selectman Hodge noted that the Muskett Ridge Bridge will be coming soon.

First Selectman Hodge noted that New Fairfield has been awarded a \$250,000 STEAP Grant to help offset expenses related to the Emergency Radio Communications project.

First Selectman Hodge noted that the town has taken in approximately \$260,000 in grants since the last BOS meeting.

- 2. To consider and act upon a proposed resolution to accept a CT Jag Local Pass through Grant in the amount of \$9,100 for car seat safety exhibit.
- 3. To consider and act upon the authorization to return \$74,500 to the General Fund for architectural fees for the Senior Center.
