<u>Public Comment</u>- Residents Paul Bruno, Karen Chance and Don Blackwell thanked outgoing Selectman Tom Corbett and Selectman Ron Oliveri for all their service to the town and wished them well in their future endeavors.

#### **Approval of Minutes**

Ron Oliveri made a motion to approve the minutes of the October 22, 2009 regular meeting as presented. Tom Corbett seconded the motion.

## <u>Discuss and possibly vote to authorize the first selectman to sign any and all contracts related to the Recovery Act Connecticut Energy Efficiency Program</u>

John Hodge made a motion that the BOS approve the following resolution: "Resolved that John Hodge, First Selectman, is hereby authorized to make, execute and approve on behalf of the Town of New Fairfield any and all contracts and amendments related to the Recovery Act Connecticut Energy Efficiency program and to execute and approve on behalf of this municipality any and all instruments a part of or incident to the above contracts and amendments, effective until otherwise ordered by the Board of Selectmen." Tom Corbett seconded the motion.

#### **Vote: 3-0-0 (Motion approved)**

First Selectman John Hodge explained that this program is a stimulus grant in the amount of approximately \$6500 to improve the energy efficiency in town buildings. Mr. Hodge noted that a large portion of this grant would be to insulate Town Hall.

# <u>Discuss and possibly vote to authorize the first selectman to sign DECD resolution pertaining to construction of three new radio towers</u>

John Hodge made a motion that the BOS approve the following resolution "WHEREAS, pursuant to C.G.S.4-66g, the Connecticut Department of Economic and Community Development is authorized to extend financial assistance for economic development projects; and WHEREAS, it is desirable and in the public interest that the Town of New Fairfield make an application to the State for \$250,000 in order to undertake the Construction of three new radio towers and to execute an Assistance Agreement. NOW THEREFORE, BE IT RESOLVED BY THE Board of Selectmen

- 1. That it is cognizant of the conditions and prerequisites for the state financial assistance imposed by C.G.S. 4-66g
- 2. That the filing of an application for State financial assistance by the Town of New Fairfield in an amount not to exceed \$250,000 is hereby approved and that John E. Hodge, First Selectman is directed to execute and file such application with the Connecticut Department of Economic and Community Development, to provide such additional information, to execute such other documents as may be required, to execute an Assistance Agreement with the State of Connecticut for State financial assistance if such an agreement is offered, to execute any amendments, decisions, and revisions thereto, and to act as the authorized representative of the Town of New Fairfield.

Tom Corbett seconded the motion.

First Selectman Hodge noted that this resolution was in reference to the STEAP Grant received for the Emergency Radio Communications project.

#### Discussion and vote on agreement for Design & Construction replacement of culverts over East Lake Brook

John Hodge made a motion to authorize the first selectman to sign an agreement/contract with Cardinal Engineering for the replacement of culverts over East Lake Brook. Ron Oliveri seconded the motion.
