# Discussion of providing a small cities grant

Grants Administrator Lisa Low approached the BOS about making a special exception and giving a \$7,500 grant assistance grant to a town resident to remediate lead on the siding of their house. There was a discussion about the difference between a small cities grant and a loan. It was noted that if the homeowner took a loan they would not be required to pay it back until the house is sold or refinanced. It was decided not to grant the special exception but noted that the homeowner could take advantage of a loan.

# **Discussion of Aquarion Water Co. Request**

First Selectman John Hodge spoke of a proposal by Aquarion Water Company to add a water line and hydrants that would service 210 residents in the Ball Pond area. The cost of this system is \$25,000. It was decided not to take action on this at this time.
