Accounting Manager Ed Sbordone spoke of possible changes for the 2010-2011 requested BOS budget. Such changes would result in a net decrease of \$2,463 or a decrease of -0.03% from the 2009-2010 BOS budget.

John Hodge made a motion that the Board of Selectmen approve budget revisions for the 2010-2011 town budget reflecting a net change of \$35,200 over the originally approved BOS 2010-2011 budget which gives a reduction from the 2009-2010 budget of \$2463.
