### **Correspondence and Announcements**

First Selectman John Hodge announced that he and Selectman Chapman went to Glastonbury for a presentation by Governor Rell and noted that the proposed acquisition of the Keiler property was approved for funding under the state's "Open Space and Watershed Land acquisition Grant Program" and the Town of New Fairfield was approved for \$180,000. The town will also contribute \$180,000 from the fee in lieu of Open Space Fund for this project.

First Selectman Hodge also noted that the town received a \$150,000 STEAP grant to construct a trail from the center of town to the Senior Center.

First Selectman Hodge noted that the town received a \$300,000 grant under the Small Cities program to assist residents for Housing Rehabilitation.

A grant was received from AT&T U-Verse in order to broadcast Channel 17 on the AT&T U-Verse system and to allow Channel 17 to be viewed on the internet and AT&T U-Verse will also give a governmental channel.

An Assistance to Firefighters grant was received in the amount of \$579,000 and an Emergency Generator grant in the amount of \$41,400.

Mr. Hodge noted that the Town of New Fairfield has received in the last six months grants totaling \$1,270,000.

Mr. Hodge noted that he has been receiving very positive feedback on the new siding on Town Hall and the Street Scape project for the sidewalk from the center of town to the Senior Center.
