First Selectman Hodge noted that there were two winners from New Fairfield in the Housatonic Resource Recovery Authority Poster contest. Winners will be presented at a BOS meeting in the near future.

First Selectman Hodge noted that the town went back to Standard and Poor's since they were bonding for the school building project. Standard and Poor's has renewed the AAA bond rating for the Town of New Fairfield. Mr. Hodge thanked the town employees, the Board of Finance and Board of Selectmen for all their hard work in achieving and maintaining this AAA rating.

John Hodge made a motion to reappoint Tom Quigley to the Inland/Wetlands Commission. Monika Thiel seconded the motion.

Budget Transfers

John Hodge made a motion to approve a transfer from Town Properties Capital in the amount of \$4,386.00 for the purpose of putting in a well pump at the Police Station. Susan Chapman seconded the motion.

<u>Vote to authorize the First Selectman to sign budget stabilization program between CIRMA</u> and the Town of New Fairfield

First Selectman Hodge noted that the BOS voted at the last meeting to accept a three-year rate lock with CIRMA for liability and workman's compensation for the town. Since the last meeting it was noted that workman's compensation was not included in this rate lock. CIRMA did however; offer the rate lock for the Board of Education. The town's annual premium for this is \$89,947.00

John Hodge made a motion that the First Selectman be authorized to sign a letter of commitment for budget stabilization between the Town of New Fairfield and CIRMA as presented. Susan Chapman seconded the motion.

Vote to authorize the First Selectman to sign application for Generator Grant

First Selectman Hodge noted that the town received a grant for a generator and was able to get a 300 kilowatt mobile generator for the Community Room at 33 Route 37. The town received notice that the town can apply for this grant with the State Department of Emergency Management and Homeland Security. It was noted that if the town does not get this grant, they may be in line to get it next year.

John Hodge made a motion to authorize the First Selectman to approve the application for a grant with the State Department of Emergency Management and Homeland Security for purposes of buying a 300 kilowatt portable generator. Susan Chapman seconded the motion.
