First Selectman John Hodge noted that the town got approval from FEMA for a bridge to connect the Senior Center with the Historic Houses. It is hopeful that the bridge will be in place by this summer.

First Selectman John Hodge noted that CIRMA has locked in the town's rates and also will be doing an equity distribution and in this case the town will get a \$26,805 refund from CIRMA.

## Vote to authorize the First Selectman to sign the State Police contract

# <u>Vote to authorize the First Selectman to file the Small Cities application in the amount of \$300,000</u>

Grant Administrator Dr. Lisa Low spoke of the Small Cities grant that provides low income homeowners with interest free loans in order to do improvement to their homes. These loans are paid back once the home changes hands. A public hearing was held immediately before this meeting and there was public support for this program.

John Hodge made a motion to approve the following resolution: WHEREAS, Federal monies are available under the Connecticut Small Cities Community Development Block Grant

BOS- Minutes 04/14/11 Page 2 of 4 Program, administered by the State of Connecticut, Department of Economic and Community Development pursuant to Public Law 93-3-83, as amended; and,

WHEREAS, pursuant to Chapter 127c, and Part VI of Chapter 130 of the Connecticut General Statutes, the Commissioner of Economic and Community Development is authorized to disburse such Federal monies to local municipalities; and,

WHEREAS, it is desirable and in the public interest that the Town of New Fairfield make application to the State for \$300,000 in order to undertake a Small Cities Community Development Program and to execute an Assistance Agreement therefore, should one be offered.

NOW THEREFORE, BE IT RESOLVED BY the Board of Selectmen:

- 1. That it is cognizant of the conditions and prerequisites for State Assistance imposed by Part VI of Chapter 130 of the Connecticut General Statutes; and,
- 2. That the filing of an application by the Town of New Fairfield is an amount not to exceed \$300,000 is hereby approved, and that John Hodge, First Selectman, is hereby authorized and directed to file such application with the Commissioner of the Department of Economic and Community Development, and to provide such additional information, to execute such other documents as may be required by the Commissioner, to execute an Assistance Agreement with the State of Connecticut for State financial assistance if such an Agreement is offered, to execute any amendments, rescissions, and revisions thereto, and to act as the authorized representative of the Town of New Fairfield.

<u>Vote to designate Hudson City Savings Bank as a depository for the Town of New Fairfield</u> First Selectman Hodge noted that the Town Treasurer Phil Cammarano has found a favorable interest rate for town funds with Hudson City Savings Bank. Banks must be preapproved with the town.

John Hodge made a motion to that pursuant to Section 7-402B of the Connecticut General Statutes the BOS hereby authorizes Hudson City Savings Bank to become a qualified depository for the Town of New Fairfield. Susan Chapman seconded the motion.
