First Selectman John Hodge announced that the budget for both the town and the Board of Education passed. Mr. Hodge noted that this was the sixth year in a row that the budget passed on the first try.

First Selectman Hodge noted that the Parks and Recreation schedule for the summer is now available at Town Hall and will be available on-line.

First Selectman Hodge noted that there will be a "Household Hazardous Waste Collection Day" on Saturday, May 21st from 9am to 2pm at the Newtown Public Works garage at 4 Turkey Hill Road in Newtown. This service is free of charge and more information can be found on either the town website or the HRRA website.

Selectman Susan Chapman noted that there is free e-recycling at the drop-off center anytime that the drop-off center is open.

Selectman Monika Thiel noted that "Building Bridges" held at the high school on April 30th was a big success.

Presentation of Plan of Development and Conservation

Planning Commission Chairman Mike Daood spoke of the Plan of Conservation and Development for New Fairfield that must be done every ten years. Mr. Daood spoke of the future growth of New Fairfield and noted that the Planning Commission is in the process of getting feedback from all boards and commissions in town. The Plan of Conservation and Development that was done in 2003 is available on the town's website with an opportunity to give comments.

First Selectman Hodge thanked the Planning Commission for all their hard work with this plan and noted that the plan done in 2003 was very expensive and thanked the Planning Commission for saving the town money.

Vote to authorize First Selectman to sign Open space and Watershed Land Acquisition Grant Agreement

First Selectman Hodge spoke of a resolution that needs to be signed for property at the end of Pine Hill. This is a 50/50 grant in which the town will pay \$180,000 from the fee in lieu of open space fund and the state will contribute \$180,000 for a total purchase price of \$360,000.

John Hodge made a motion to resolve that John Hodge, First Selectman of the Town of New Fairfield be and hereby is authorized to execute on behalf of the Town of New Fairfield, an Open Space and Watershed Land Acquisition Grant Agreement and a Conservation and Public Recreation Easement and Agreement with the State of Connecticut for financial assistance to acquire permanent interest in land known as the Keeler Property, New Fairfield, OSWA-405, and to manage said land as open space pursuant to Section 7-131d of the Connecticut General Statutes. Susan Chapman seconded the motion.

After a lengthy discussion, John Hodge made a motion to call the question on the above referenced motion. Susan Chapman seconded the motion.
