Call To Order First Selectman John Hodge called the meeting to order at 7:30pm

Correspondence and Announcements

First Selectman John Hodge spoke of the storm that happened tonight and noted that many homes don't have power. Mr. Hodge thanked the Emergency Service people and First responders for all their hard work during this storm and noted that no one was injured in this storm.

Mr. Hodge spoke of the artificial turf at the High School and noted that there was some premature wear and tear on the turf and the manufacturer has agreed to a complete replacement of the field. As a result the field and track will be closed for approximately 45 to 60 days.

First Selectman Hodge spoke of a grant application to help replace the bridge over Ball Pond Brook on Saw Mill Road. The town received notice today that they will receive an 80% grant on the project cost of \$1.4 million.

Proclamation

First Selectman John Hodge noted that he and Selectman Susan Chapman attended Relay for Life on Saturday, June 4th and it was a wonderful event. Mr. Hodge presented Kristen Scappaticci with a Proclamation for all her work in running Relay for Life over the years.

Vote on Conditional Hazard Mitigation Plan

First Selectman John Hodge spoke of a Conditional Hazard Mitigation Plan that the town would like to implement. Having this plan would make the town eligible for certain grants that they otherwise may not be eligible for. Scott Bignotti from the firm of Malone & McBroom spoke of the process of implementing this plan. The first part of this plan describes the FEMA program and the second part of the plan is specific to New Fairfield. This plan describes the geography and topography and things that tie into the town. Another part of the plan describes areas that are more susceptible to flooding or other types of hazards. The top three projects for New Fairfield were to upgrade the East Lake Brook Road crossing, improve the Candlewood Corners drainage system and to upgrade the culvert at Bigelow Corners to reduce flooding. Once adopted this plan needs to be updated every five years.

John Hodge made a motion that resolved that the Board of Selectman approve the Natural Hazard Predisaster Mitigation Plan at the meeting of June 9, 2011 as presented. Monika Thiel seconded the motion.

Pedestrian Bridge Update

First Selectman John Hodge spoke of the foot bridge that will be behind the Senior Center to the Historic Houses. A temporary bridge was put in when the Historic Houses were moved. A portion of the bridge was purchased thereafter. With the approval of the town land use boards and the knowledge of the DEP the bridge was shrunk to about 12 feet. Thereafter a local resident complained and that this bridge was potentially impeding the flood way over Ball Pond Brook. DEP then demanded that the bridge be removed within six months. Since then the town has been working with FEMA to prove that the bridge will not cause flooding anywhere else. The town will be filing with the Inlands/Wetlands board to put the bridge in. The cost of the bridge is being paid for from a STEAP Grant.

Supplement CLG Grant Application for Historical Preservation Inventory

Stacey Kenny from Preserve New Fairfield, Inc. and the Historic Properties Commission spoke of a grant application for the Connecticut Commission on Culture and Tourism regarding historic houses in town and appreciation for Historic Resources. Ms. Kenny gave an estimated project timeline.

John Hodge made a motion to authorize the first selectman to sign an application for a Connecticut Commission on Culture and Tourism Supplemental Certified Local Government grant for the CLG Program for 2011 as presented and to be attached to the minutes of this meeting. Susan Chapman seconded the motion.

STEAP Grant application for the Library

First Selectman John Hodge spoke of the potential to apply for a STEAP Grant for the Library. The maximum amount of the STEAP Grant is \$500,000. Mr. Hodge noted that if the town has additional funds available for library it is possible that a second referendum to build a new library on Gillotti Road by the High School and Middle School may pass. Mr. Hodge noted that grant notification for the STEAP grant should come back in early September.

John Hodge made a motion to authorize the first selectman to sign a STEAP Grant application for a maximum of \$500,000 to be used towards the construction of a new library. Susan Chapman seconded the motion.

There was a question at the May 18th BOF meeting as to whether or not State Representative Richard Smith was able to represent a board in town or if that would constitute a conflict of interest. First Selectman John Hodge read a letter from Peter Lewandowski, Assistant General Counsel for the Office of State Ethics (Attached to the minutes). According to Mr. Lewandowski there is no conflict of interest and Mr. Smith can represent a board in town.

Donation to Parks and Recreation

John Hodge made a motion to accept a donation in the amount of \$500 from Kevin Clark for improvement to be made on the basketball courts and a \$2,500 donation from Stop & Shop for a sponsorship of the drive-in movie *Megamind* on Friday, July 15th and \$2,500 from Union Savings Bank for sponsorship for the drive-in movie *Toy Story 3* on Friday, August 19th. Susan Chapman seconded the motion.
