First Selectman John Hodge announced that the track at the High School has been redone and is reopened.

Vote to authorize the First Selectman to sign the Homeland Security grant

Jean Flynn noted that the State of Connecticut received just under \$2.5 million from a grant from Homeland Security. The State of Connecticut is split into five homeland security regions. New Fairfield is one of 43 towns in Region 5. Region 5 has been allocated \$856,875.00 for regional projects. In order to receive this money a MOA must be signed.

John Hodge made a motion to authorize the First Selectman to sign the Homeland Security grant as presented. Susan Chapman seconded the motion.

Speed Limit on Warwick Road

Many residents of Warwick Road spoke of the new 40 mph speed limit. Mr. Hodge noted that the state approves the speed limits for the roads. It was noted that it is not advisable to set an unrealistic speed limit.

Mr. Hodge noted that speeding on Warwick Road has become a problem and noted that he would like to hire a traffic engineer to see the exact situation on Warwick Road.

Warwick Road resident Pat Del Monaco spoke of the busiest times of day. There was a discussion of bus routes and it was suggested having students get only get on the bus on certain sides of the road. Selectman Susan Chapman will talk to the Town's Purchasing Agent Patty Mota regarding the bus schedule.

John Hodge made a motion to authorize the First Selectman to obtain a traffic engineer for the purpose of looking at the speed limit at Warwick Road. Susan Chapman seconded the motion.
