Discussion of construction of a new baseball field at New Fairfield High School

Scott Roberti from New Fairfield Baseball spoke of the shortage of fields in New Fairfield and the league's desire to build a new baseball field at New Fairfield High School.

First Selectman Hodge asked that this issue go back to the Board of Education for clarification and a further look at field fees agreements and noted that this will have to go to a Town Meeting. Mr. Hodge noted that this agreement will need to be revisited every ten years and noted that he would like to see something in the agreement that addresses the issue of what would happen if the baseball program is no longer in existence and

Vote to authorize the first selectman to sign communications tower option to lease agreement

First Selectman Hodge spoke of an amendment for the communications tower lease. This amendment is for New Cingular Wireless for \$8400/per year and escalates moving forward. This amendment was sent to the structural engineer for this tower. Mr. Hodge noted that in paragraph #4 of this agreement New Cingular is looking for "right of first refusal". Mr. Hodge noted that he did not agree with this part of the agreement.

John Hodge made a motion to approve the third amendment to the communication tower option to lease and lease agreement with New Cingular Wireless PCS LLC with the proviso that paragraph number 4 of the document be not approved by the Board of Selectmen. Susan Chapman seconded the motion. **Vote: 2-0-0 (Motion approved)**

<u>Vote to authorize the first selectman to sign proposal for Appraisal Litigation support services for</u> <u>Candlewood Lake Causeway</u>

First Selectman John Hodge spoke of a tax appeal case with First Light (owner of Candlewood Lake). The town has made numerous attempts to settle this. At this point a consultant is needed for this issue.
