Approval of Minutes

Susan Chapman made a motion to approve the minutes of the March 8, 2012 regular meeting as presented. Mike Gill seconded the motion.

Susan Chapman made a motion to approve the minutes of the March 15, 2012 special meeting as presented. John Hodge seconded the motion.

Executive Session

John Hodge made a motion to go into Executive Session at 7:34 pm and to invite Town Labor Counsel John Shay into the Executive Session. Susan Chapman seconded the motion.

Susan Chapman made a motion that the BOS consider the termination of the Director of Buildings and Grounds and Parks and Recreation. Mike Gill seconded the motion.

Library Project

Library Director Linda Fox spoke of the proposed renovations to the existing library and gave a power point presentation which included pictures of the existing library. Such renovations would include updating of lighting and air conditioning, and making the building ADA compliant. An elevator would need to be added and the bathrooms, doors and staircase would need to be improved. The renovations would include an update to the Program Room and the Community Room.

This project would be done in two phases with a cost of \$565,000 for the first Phase and \$390,000 for the second Phase. It was noted that the library would use money that they have accumulated as well as grants and donations to fund this project and will be done over two fiscal years.

Architect Steve Lazarus from the firm of Lazarus and Sargeant spoke of the project and noted the most important improvements needed.

John Hodge made a motion to recommend to a Town Meeting an appropriation not to exceed \$300,000 from the capital and nonrecurring fund for the purpose of funding Phase I of the library renovation. Mike Gill seconded the motion.

Library Board Chairman Gail Lehman thanked the Board of Selectmen for their support with this project. Anyone wishing to view the detailed estimate and plans can get a copy at the library or via the library's website.

It was decided that this project would be voted on at the same time as the budget referendum in May as a separate issue. It was noted that this money is coming out of the unappropriated capital and nonrecurring and will not increase taxes.

Gift from Friends of the Senior Center

Mike Gill made a motion to accept a gift in the amount of \$652.58 from the Friends of the Senior Center. John Hodge seconded the motion.

Vote on Subordination for Housing Rehabilitation Application

First Selectman John Hodge spoke of homeowner in town looking to apply for a housing rehabilitation loan to repair his septic tank.

First Selectman Hodge noted that he spoke to approximately one-third of the references for this company.
