### **Discussion of Temporary Budget Freezes**

First Selectman John Hodge spoke of a settlement of a lawsuit with First Light that happened after the property underneath Candlewood Lake was reassessed. The value was raised in 2009 and the power company sued the town regarding the value of the property. A settlement was reached and it was noted that First Light has been overpaying in taxes. An adjustment has been made that will result in a shortfall of revenue of \$494,000 for 2012-2013.

First Selectman Hodge presented the following resolution for recouping the shortfall:

These freezes will be reevaluated after six months.

John Hodge made a motion that the BOS approve the temporary freezes to the 2012-2013 budget as presented. Mike Gill seconded the motion.

#### Management Agreement for tower at Tower Hill

First Selectman John Hodge noted that a Public Hearing was held immediately prior to this meeting regarding the cell tower at Tower Hill. This tower has potential as a cellular tower. The town put out a RFP for a tower management company that will find tenants for the tower. A company called Homeland Towers LLC was found for this purpose. A contract with Homeland Towers is currently being reviewed for this.

Mike Gill made a motion to authorize First Selectman John Hodge to sign the site management agreement with Homeland Towers LLC after four minor changes have been made to the contract. John Hodge seconded the motion.
