Discussion of vote to set a Town Meeting for proposed Blight Ordinance

Selectman Mike Gill noted that he and Selectman Susan Chapman along with Building Inspector Chris Baldwin and Director of Health Tim Simpkins have been working on a Blight Ordinance for the town. This proposed ordinance was recently sent to Town Counsel Jack Keating for review. It was decided that a Public Hearing regarding this will be on Thursday, September 27th at 7:00pm. A copy of the proposed ordinance will be available in the Selectman's office and also on the website.

Vote on additional funding for Broadcast Server for Channel 17

Ray Juskiewicz spoke of the Broadcast Servers for Channel 17 and Channel 99. Currently, the programming is done through DVD players. However, the new DVD players are now equipped with an Energy Saver feature that will go off after 30 minutes of not being used. As a result, the programming will not go on the air. Mr. Juskiewicz noted that a solution to this would be to purchase a server that will store all of the programming. The total cost of this would be \$7,833.00. The budget for Channel 17 can cover \$3,000 of this but there will be a shortfall of \$4,833. The BOE has approved to cover half of this shortfall for an amount of \$2,417.

John Hodge made a motion to make an Intra-Departmental transfer from line item 1-001-4110-110 to line item 1-001-4110-320 in the amount of \$2,417.00 for the server for Channel 17. Susan Chapman seconded the motion.
