Discussion on the expansion of the New Fairfield/Sherman Animal Welfare Shelter

Mike Troiano from the New Fairfield/Sherman Animal Shelter spoke of a proposal for a 550 square addition to the shelter. The proposed addition was previously approved by the Planning and Zoning commissions. This addition will still fit within the boundary of land. There was a brief discussion of the total cubic footage of the property and the water supply in case of fire.

Vote on MOA regarding Homeland Security Funding

Director of Emergency Management Jean Flynn spoke of a grant that Region 5 receives every year. This year the amount of the grant is \$507,748. A Region 5 team meets to decide how to spend the money from this grant in a way that benefits all the towns in the region.

John Hodge made a motion to take a 5-minute recess at 8:30pm to discuss the Resolution regarding MOA for Homeland Security Funding. Susan Chapman seconded the motion.

John Hodge made a motion to resolve that the Board of Selectman may enter into with and deliver to the State of Connecticut Department of Emergency Management and Homeland Security any and all documents which it deems to be necessary or appropriate; and further resolve, the John Hodge, First Selectman of the Town of New Fairfield, is authorized and directed to execute and deliver any and all documents on behalf of the Board of Selectmen and to do and perform all acts and things which he deems to be necessary or appropriate to carry out the terms of such documents, including but not limited to, executing and delivering all agreements and documents contemplated by such documents. The undersigned further certifies that John Hodge now holds the office of First Selectman and that he has held that office since November 22, 2005. Susan Chapman seconded the motion.
