Historic Properties Commission presentation

Historic Properties Commission members Jerry Bielizna and Stacy Kenny spoke of the Creamery in town and noted that they wanted to seek a local historic designation for the Creamery. The local register automatically makes the Creamery eligible for state register listing which enables the Creamery to be eligible for state and non-profit grants. The Historic Properties Commission would like to apply for a Connecticut Trust for Historic Preservation grant to conduct a feasibility study. This study would determine if the Creamery has enough historic value in the interior finishes to warrant saving the building, potential uses for the Creamery and a ballpark figure for saving the Creamery. It was noted that the town must match the amount of the grant. The study is expected to cost approximately \$20,000 which would mean the grant would be for \$10,000 and the town would be responsible for \$10,000.

The Historic Properties Commission believes that the Creamery was once a barn and is historically significant. The main purpose for this grant is to determine if the Creamery is worth saving. The process of this study may

It was noted that the Board of Selectmen will have the final say in what happens to the Creamery. There was a discussion among the members of the BOS and it was decided that this issue be tabled until the next regular BOS meeting on January 24th. The BOS asked the Historic Properties Commission to come back with a more detailed report at that time.
