Discussion on Historic Properties presentation of Creamery

Historic Properties Commission Chairman Stacy Kenny spoke of the commission's plans for the Creamery in New Fairfield. At a prior meeting, the commission spoke of applying for a Connecticut Trust for Historic Preservation grant to conduct a feasibility study. This study would determine if the Creamery had enough historic value to warrant saving the building. Since the last BOS meeting, the commission has decided to go a different route and applying directly to the State to get the Creamery listed on the State Historic Register. This would make the building eligible for historic preservation grant money.

Faline Schneiderman spoke of the history of the Creamery and noted that the exact age of the building but believed it predated 1900 and is one of the oldest structures in town. Previous grants have been given towards this house. Ms. Schneiderman gave the BOS a copy of the Historic Resource Inventory pages and spoke of work that could potentially be done with the grant money. The Historic Properties Commission noted that they will continue to do research on this structure.

The entire BOS thanked everyone on the Historic Properties Commission for all their hard work.
