# **Correspondence and Announcements**

First Selectman Susan Chapman announced that New Fairfield received the Heartsafe Community designation which is good for the next three years. First Selectman Chapman thanked Jim Stead for all his work in putting the package for Heartsafe together for the town.

Susan Chapman noted that Pete Viola has resigned from the Ball Pond Advisory Committee and thanked him for his service.

Susan Chapman noted that Tree Warden Keith Norton has resigned and thanked him for his service to the town.

Susan Chapman stated that the Town of New Fairfield received \$400,000.00 in grants to help families this year. This will help 10 to 12 families this year.

# <u>Discuss and Vote to Authorize the First Selectman to Sign the Agreement for the Replacement of the Saw Mill Road #1 Bridge</u>

Susan Chapman read a Resolution to authorize to sign an agreement entitled, "An Agreement between The State of Connecticut and the Town of New Fairfield for the development of contract, plans and specifications in estimates in conjunction with the replacement of the Saw Mill Road #1 Bridge, Bridge No. 05104, utilizing Federal Funds from the Highland Bridge Program adopted by the Board of Selectman in the Town of New Fairfield, Connecticut this 13th Day of August, 2013."

Susan Chapman made a motion to vote to authorize the First Selectman to Sign the Agreement for the Replacement of the Saw Mill Road #1 Bridge. John Hodge seconded the motion.

#### **Library Construction Presentation**

Library Board Chairman Gail Lehman gave a presentation regarding past and future fundraising activities for the Library renovation project. Scheduled events include a Wine and Beer Tasting Event for Thursday, November 7, 2013 and Holiday Event scheduled for Saturday, November 30, 2013. The Holiday Event will be a joint venture with the Park and Recreation Department. The Library Board has raised monies from donations and fundraising events, but has not yet reached the goal of \$450,000.00. It was noted that the decision to renovate the Library is unanimous among the Library Board and they are not looking to build a new library at this time. The Board of Selectman stated that they are in full support of the Library Renovation project.

Gail Lehman spoke of the "Imagination Library" sponsored by the Dolly Parton Foundation and administered through the United Way for children from birth to age 5. This program sends children that

register a book every month until they are five years old. The New Fairfield Library started this program one year ago and has been very successful. To date, the New Fairfield library has registered 600 children. The Library staff and board met with members of the Derx Foundation on July 30<sup>th</sup> regarding a possible donation to the library renovation project. It was noted that the Derx Foundation usually makes announcements of their grants in October. If a grant is received from the Derx Foundation, it will be distributed in December.

Library Director Linda Fox asked the BOS to approve an application for the Library Construction Grant. This grant would concentrate on handicap access, code compliance, remodeling and energy conservation. State monies up to \$1.4 million for renovations may be available through this grant.

The Library Board has still not heard about the STEAP Grant.

## Vote to Authorize the First Selectman to sign a contract for the Library Construction Grant

Susan Chapman made a motion to read: Be it resolved that Susan Chapman, First Selectman, of the Town of New Fairfield, CT is empowered to apply for the State public library construction grant and to execute and deliver the name on behalf of this organization in certain contract with the Connecticut State Library in the State of Connecticut for the State Public Library Construction Grant. John Hodge seconded the motion.
