The Board of Education received a matching grant in the amount of \$157,000 for security.

Barn Brook Estates bond reduction

Mike Gill made a motion to approve the bond reduction as recommended by the Planning Commission for Barn Brook Estates from \$175,000 to \$58,900. John Hodge seconded the motion. **Vote: 3-0-0 (Motion approved)**

Draw down on bond for Wild Turkey Estates

There was a discussion of the outstanding bill for engineering fees for Wild Turkey Estates. First Selectman Chapman noted that this bill has been outstanding for over a year. A letter was sent on behalf of the builder from their attorney and a response was sent from Town Counsel Jack Keating noting that this bill needs to be paid. It was noted that the Town Engineer has been paid and that this bill is owed to

Assistant Agreement with the State of Connecticut

First Selectman Chapman noted that this resolution was needed in order to authorize her to sign for the Small Cities Grant.

Susan Chapman made a motion to approve the following Resolution:

Whereas Federal monies have been made available under the Connecticut Small Cities Community Development Block Grant Program, administered by the State of Connecticut, Department of Housing pursuant to Public Law 93-3 83 as amended; and

Whereas pursuant to Chapter 127c and Part VI of Chapter 130 of the Connecticut General Statutes, the Commissioner of the Department of Housing is authorized to disburse such Federal monies to local municipalities; and,

Whereas, in 2013 the Town of New Fairfield has been awarded \$400,000 in order to undertake a Small Cities Community Development Program and to execute an Assistance Agreement upon award.

Now, Therefore be it resolved that the Board of Selectman of the Town of New Fairfield

- 1. That it is cognizant of the conditions and prerequisites for State Assistance imposed by Part VI of Chapter 130 of the Connecticut General Statutes; and,
- 2. That the First Selectman, Susan Chapman, is hereby authorized and directed to execute an Assistance Agreement with the State of Connecticut for State financial assistance; to execute such other documents as may be required by the Commissioner, to execute any amendments, rescissions, and revisions thereto, and to act as the authorized representative of the Town of New Fairfield.

Hazard Mitigation Grant Program

First Selectman Chapman noted that a grant has been received from FEMA to replace the generator at Company A Firehouse. The approximate value of this generator is \$81,000.00. A special BOS meeting will be held on Friday, November 15th to set a date for a Town Meeting to accept this grant.

Town Consent Adoption Agreement

Selectman Mike Gill spoke of the collection of electronic recycling. An RFP was put out by HRRA for a new firm to collect the recyclables in the region. A company called Ecco out of Vessel, NY was chosen but is going out of business. Their business is being transferred to Newtech Recycling in Somerset, NJ.

HRRA is going to have a 90 trial with Newtech and will go out for a new RFP if it doesn't meet performance.

Mike Gill made a motion to authorize the First Selectman to sign the Town Consent Adoption agreement between the Town of New Fairfield and HRRA to allow Newtech to take over the contract for collection of Ewaste. John Hodge seconded the motion. Vote: 3-0-0 (Motion approved)
