- 2. To consider and act upon the appropriation of Education Expenditures totaling \$40,817,706.00 from the General Fund, and \$631,631.00 from the Capital and Non-Recurring Fund, as recommended by the Board of Finance, for the fiscal year commencing July 1, 2014 and ending June 30, 2015.
