<u>Discussion and vote to authorize the First Selectman to sign the 2015 STEAP Grant application for pedestrian walkways</u>

Susan Chapman made a motion to authorize the First Selectman to sign the 2015 STEAP Grant application for pedestrian walkways. Mike Gill seconded the motion.

First Selectman Chapman noted that this is the exact same application as last time and the town would like to reapply.

Discussion and vote to authorize the First Selectman to sign the Dispatchers Union Contract

Susan Chapman made a motion to authorize the First Selectman to sign the Dispatchers Union Contract. Kim Hanson seconded the motion.

First Selectman Chapman noted that this is a reopener for wage increases. The union has already approved wage increases for the next three years. The entire contract is up on December 31, 2017.

<u>Discussion and vote to authorize the First Selectman to sign the MOU with the Dispatchers' Union</u> First Selectman Chapman noted that the town can reopen the Dispatchers' Union contract in order to hire a fourth dispatcher, but the town is not obligated to keep four dispatchers.

Susan Chapman made a motion to authorize the First Selectman to sign the MOU with the Dispatchers' Union. Kim Hanson seconded the motion.

Vote: 3-0-0 (Motion approved)

There was a brief discussion of whether or not it was necessary to hire a fourth dispatcher. It was decided that the board will vote on hiring another dispatcher at a time in the future via the Personnel report.

General Discussion: Items to be brought up by selectmen for future agendas

Selectman Mike Gill spoke of his concerns with getting something done with the Green House/Creamery by October 31st. First Selectman Chapman noted that money has been proposed to be set aside from the budget surplus for the Creamery. First Selectman Chapman suggested that if this transfer is approved, the town should hire an architect to look at options for this building.

Kim Hanson made a motion to adjourn the meeting at 7:50pm. Mike Gill seconded the motion.
