Susan Chapman made a motion to approve a \$250.00 donation from Union Savings Bank, North East Irrigation and Mitchell Oil to the Turkey Run. Mike Gill seconded the motion.

Discussion and vote to approve the purchase a new Engine 12 for the New Fairfield Volunteer Fire Dept.

Pete Benzinger from the Fire Department spoke of the need to replace Fire Engine 12 for the Squantz Fire Department. He noted that there was approximately \$560,000 in the reserve fund for the fire department and spoke of two bids that were received for this truck. There was a brief discussion of the age of the old fire truck and the expected life of the new truck. It was noted that the policy is for the town to pay 75% of the cost of the truck and the fire dept. will fund 25% of the truck out of the reserve fund.

First Selectman Chapman thanked the fire department for all their hard work in researching this purchase.

Susan Chapman made a motion to approve the transfer of \$378,750.00 from the reserve fund for a new fire truck Squantz Pond Fire Department. Mike Gill seconded the motion.

Discussion and vote to add nine additional plots to the Community Garden

Gary Mummert spoke of the success of the community garden for its first year and noted that 12 garden beds were put in. Mr. Mummert provided drawings and requested an additional nine plots. These additional plots would not require an additional water source and minimal fundraising would be required. It was noted that over 30 pounds of vegetables have been donated to New Fairfield Social Services this season.

Susan Chapman made a motion to approve an additional nine plots at the Community Garden. Mike Gill seconded the motion.
