Susan Chapman made a motion to approve the Personnel Report dated as presented. Kim Hanson seconded the motion.

New Fairfield Veteran's presentation

Jim Merenda from the New Fairfield Veterans Association spoke of the Veterans Association need for a new place to house their belongings and vehicles. Mr. Merenda spoke of the various missions and projects that the Veterans Association provides to town. Previously, the association had a garage to keep their belongings but that is no longer available. The Veterans are currently looking for ideas to put a structure that would be approximately 40' by 24' in size. Mr. Merenda spoke of the possibility of putting this structure by the Drop Off Center and noted that he met with the Town of New Fairfield Health Director and the Zoning Enforcement Officer regarding this.

First Selectman Susan Chapman spoke of why the option of the Drop Off Center may not be the best place and noted that New Life Community Church on Beaver Bog offered some space for the structure. Selectman Mike Gill spoke of problems that occurred with the Fire Dept. when looking to use property by the Drop Off Center.

First Selectman Chapman encouraged any residents that may be watching this meeting that may have ideas for a location to call either the Veterans Association or her office.

Presentation on Route 37 walking trail

Peter Hearn spoke of a proposal for a trail around Margerie Reservoir that could be used for pedestrians and bicycles. This trail would connect into Danbury. He noted that the recent Plan of Conservation and Development by the Town of New Fairfield encouraged the building of walking and biking trails. Mr. Hearn spoke of the grant process in order to secure funding for this project and noted that he will be meeting with the Danbury City Council next week to ask for their endorsement.

There was a discussion among the members of the Board of Selectmen regarding this process. First Selectman Susan Chapman noted that she spoke with the Mayor of Danbury regarding this and there were some concerns about trails around drinking water reservoirs. First Selectman Chapman noted that the town applied for a STEAP grant in order to put sidewalks in town, and is awaiting results of that grant. The BOS decided that they liked the concept of this project but would like more information and to know the opinion of the Danbury Council.

Mike Gill made a motion to endorse the concept of the Margerie Reservoir Community Trail. Susan Chapman seconded the motion.

Agreement between Town of New Fairfield and the New Fairfield Volunteer Fire Dept.

First Selectman Susan Chapman noted that the BOS met with the Fire Department regarding the agreement with the town for purchasing new equipment. Currently, the agreement is that the town will pay 75% of the price of the equipment and the Fire Department will pay 25%. It was noted that it is getting increasingly difficult for the Fire Department to come up with the 25%. It was decided to amend this agreement to make it 85% town's responsibility and 15% Fire Department responsibility and to revisit this plan in five years.

Susan Chapman made a motion to approve the agreement between the Town of New Fairfield and the Volunteer Fire Dept. Mike Gill seconded the motion.

Vote to accept the bank offer for 6 Hammond Road

Susan Chapman spoke of a property in New Fairfield that received a Small Cities grant. The balance on this lien is currently \$21,000. This property went into foreclosure and the bank has offered the town \$3,000 towards this lien. Mike Gill asked that the BOS check with Town Counsel to see if there is any way to protect the town in the future so that this will not happen with another property.

Susan Chapman made a motion to accept the offer of \$3,000 from the bank regarding 6 Hammond Road. Mike Gill seconded the motion.
