Susan Chapman made a motion to approve the Personnel Report dated September 22, 2016 as presented. Mike Gill seconded the motion.

Discussion and vote on ambulance purchase

Fire Chief Bruce Taylor spoke of the purchase of a new ambulance for the Fire Department and noted that they have chosen to purchase from New England Fire Equipment. The bid price for this ambulance is \$182,688.00. The Fire Department is requesting \$195,000.00 from the Fire Department Reserve fund less 15% (\$29,250) which will be funded by the Fire Department for a total withdrawal from the Reserve Fund of \$165,750. The build time for this ambulance is 185 days.

Mike Gill made a motion to authorize the purchase 91-1 ambulance for an amount not to exceed \$195,000 with the Fire Department maximum contribution of \$29,250 and a withdrawal of \$165,750 from the Reserve Fund. Susan Chapman seconded the motion.

Discussion and vote on 4 Guys Fire Apparatus

Pete Benzinger from the New Fairfield Fire Dept. spoke of a contract with 4 Guys Fire Apparatus and a penalty clause for the inability of the company to deliver the fire truck by the agreed upon date. It was noted that the bond was signed on October 1, 2015 with a promised delivery date of October 26, 2016. The penalty would begin on October 27, 2016.

John Cares from 4 Guys Fire Apparatus spoke of the process and of the building of apparatus and approached the Board of Selectman with a possibility of negotiating the penalty. The BOS discussed the consequences of renegotiating the contract and decided not to renegotiate the contract with 4 Guys. Susan Chapman will contact Town Counsel to ask him to draft a letter to 4 Guys on behalf of the Town to put them on notice.
