Jen Iannucci from HRRA spoke of a survey given to New Fairfield residents regarding composting. Seventy residents participated in this survey and gave opinions of whether they would be interested in a composting disposal if available. This survey was compared to results from surrounding towns. Ms. Iannucci gave a description of composting systems and spoke of rules and regulations from the State regarding disposal of trash and recycling. She spoke of a device called the Earth Tub used for composting and noted that the price is approximately \$10,000.00. It as noted that New Fairfield received a recycling reward recently for an amount of approximately \$7,000 which can be used towards composting devices. There was a discussion of money that can be saved by composting.
