Main topics of discussion for areas to cut included road repair and paving, the excavator, phone lines and the proposed basketball court at the playground.

\$5,000.00- Saw Mill Bridge for a total of \$150.000.00 worth of proposed cuts. Mike Gill seconded the motion.

Candlewood Lake Authority Budget

The BOS discussed the CLA in the context of the 2016-2017 BOS budget. The BOS expressed their frustration with the CLA's accounting methods and overspending of their budget.
