#### **Discussion of Budget surplus**

It was noted that the budget surplus for 2016-2017 is approximately \$647,000 from the BOE and the Town. There was a discussion of using this surplus to fill gaps created by the cuts to New Fairfield from the State budget. There was a brief discussion of getting an opinion from the auditors as to what a surplus can be used for. It was noted that the Fire Department has sent a request for their surplus.

#### **Discussion of State Budget**

Susan Chapman noted that the State still has no budget. It was noted that a legal opinion was received from Town Counsel Jack Keating that Capital and Nonrecurring money cannot be used for operating expenses.

Kim Hanson spoke of a lawsuit started by the Connecticut Education Association by other towns in Connecticut against Governor Malloy regarding this budget. He suggested getting an opinion from Town Counsel as to what it would cost the Town and what the exposure would be to file an amicus to this lawsuit.
