 Inland Fisheries Division to request 175 carp for the spring of 2015 (or fall if need-be)
- Update on matters before Wetlands Commission
 - February meeting scheduled for February 24, 2015
 - At January 20, 2015 meeting:
 - 146 Ball Pond Rd, repair/replace stone seawall & planters, map 34, block 9, lot
 2, Ricci. The Commission feels the planters need to be removed, but there was no definite order to remove them; issue was continued
 - 148 Ball Pond Road Cynthia Stevens met with the Zoning Officer regarding the boulders and vehicles on the property
