#### **Correspondence and Announcements**

First Selectman Pat Del Monaco noted that a schedule of Police overtime hours was provided to the Board of Selectmen in response to a request from Selectman Kim Hanson.

Selectman Khris Hall noted that preparations have begun for New Fairfield Day to be held on Saturday, September 15<sup>th</sup>. Anyone interested in participating should contact the Selectmen's office.

#### **Public Comment and Participation**

John McCartney gave a brief description of the findings of the New Fairfield Police Committee and spoke of the cost of hiring full-time officers vs. overtime for existing police officers. He suggested that a full-time officer be hired as a School Resource Officer instead of using overtime at the schools. First Selectman Pat Del Monaco encouraged Mr. McCartney to attend the School Safety Committee and give his opinion.

Jennifer Brakenwagen asked about the process of hiring the company for brush removal for the private communities and why it wasn't put out to bid.

Greg Moore spoke of notification of the cancellation of the July 26<sup>th</sup> meeting. The BOS explained how to find the agenda and cancellation notices on the Town's website.

## **Debris Removal update**

Pat Del Monaco noted that there are approximately 6-8 days left for the debris clean-up. In response to Mrs. Brakenwagen's question during public comment, she noted that there was an addendum to the contract with Supreme Industries to do the private roads since they have the necessary equipment and proper certification from FEMA. This would allow the Town to pursue FEMA reimbursement.

## Squantz Pond update

The Town is continuing to enforce parking regulations on and around Squantz Pond. First Selectman Del Monaco asked residents to call dispatch for illegally parked cars and **NOT** 911. Anyone with any questions or concerns can also call the Selectmen's office.

## <u>Approve Warning for Special Town Meeting to approve the sale of the Municipal Water</u> <u>System to Aquarion</u>

Pat Del Monaco made a motion to approve the following Town Warning: Notice is hereby given to the electors of the Town of New Fairfield and those entitled to vote at Town Meetings that a Town Meeting will be held on August 20, 2018 at 7:30 pm in the Community Room at 33 Route 37 for the following purposes- To consider and act upon the sale of the assets of the municipal water system located at 4 Brush Hill Road to Aquarion Water Company of Connecticut, including associated easement rights and leases related to the sale. Khris Hall seconded the motion.

## <u>Vote to approve funding SRO assignment at New Fairfield Middle School and to set a date for</u> <u>a Special Town Meeting to approve said appropriation</u>

Pat Del Monaco noted that the audit report recommended having a SRO in the Middle School. She spoke of what can be funded with \$120,000. There was a discussion of the process of this and whether this approval should wait until it is formally acted on by the Board of Education. It was noted that the next BOE meeting is scheduled for Thursday, August 16<sup>th</sup>. The next meeting of the BOF is scheduled for Wednesday, August 15<sup>th</sup>.

Pat Del Monaco made a motion to recommend to the Board of Finance an appropriation of \$120,000 from the 2017-2018 operating surplus for the funding of an SRO in the New Fairfield Middle School. Khris Hall seconded the motion.

Pat Del Monaco made a motion to amend the previous motion to read that the BOS will recommend to the Board of Finance an appropriation of \$120,000 from the 2017-2018 operating surplus for the funding of an SRO in the New Fairfield Middle School should it be requested by the Board of Education. Kim Hanson seconded the motion.
