First Selectman Pat Del Monaco noted that this is the final weekend for the Haunting on the Hollow. Due to the possibility of weather cancellation on Saturday, October 27th, she encouraged residents to attend on Friday night.

Approval of Minutes

Kim Hanson made a motion to approve the minutes of the October 11, 2018 regular meeting as presented. Khris Hall seconded the motion. **Vote: 3-0-0 (Motion approved)**

Budget Transfers

Finance Director Ed Sbordone spoke of the closing out of the Ball Pond Road Repair (Aquarion) project and noted that approximately \$84,000 will be put back into the Town Properties Capital Budget. He also spoke of additional projects that need to be funded for an approximate total of \$23,000.00

There was a brief discussion of the design for the pedestrian safety signage and not having an approximate cost for the design.

Pat Del Monaco made a motion make a transfer **to** the Town Properties Capital account in the amount of \$84,469.78 (Ball Pond Road Repair (Aquarion) and a transfer **from** Town Properties Capital in the amount of \$23,000.00 (\$5,000-Pedestrian Safety Signage) (\$5,000-Bigelow Road and Route 39 intersection) (\$7,000.00-Generator hook up-Police Department) and (\$6,000.00 Annex Generator). Kim Hanson seconded the motion. **Vote: 2-1-0 (Motion approved-Kim Hanson opposed)**

Appointments

Kim Hanson made a motion to reappoint Pete Viola to the Water Pollution Control Authority. Khris Hall seconded the motion. **Vote: 3-0-0 (Motion approved)**

NEW BUSINESS

Vote to accept donations from the New Fairfield Community Garden Committee

Pat Del Monaco made a motion to accept with gratitude a donation from the New Fairfield Community Garden Committee in the amount of \$200.00. Khris Hall seconded the motion. **Vote: 3-0-0** (**Motion approved**)

It was noted that this donation will go to Parks and Recreation.

Discussion of possibility of establishing Economic Development Commission

Pat Del Monaco spoke of the possibility of establishing an economic development commission to do studies, surveys, marketing and outreach efforts to attract businesses to New Fairfield and to fill some of the empty store fronts in town. It was noted that this has been successful in surrounding towns. Selectman Kim Hanson expressed concern of having additional commissions in town and the difficulty of measuring the success of this commission. It was decided to continue this discussion at future meetings.

OLD BUSINESS

Vote to adopt Town of New Fairfield Debt policy

Kim Hanson made a motion to adopt the Town of New Fairfield Debt policy. Khris Hall seconded the motion. **Vote: 3-0-0 (Motion approved)**

Recommend to Board of Finance an appropriation of the 2017/2018 surplus

Pat Del Monaco noted that the BOS voted previously to ask the Board of Finance for 100% of the 2017-2018 surplus to be used for a public works vehicle and dock replacement. At their October 17th meeting, the BOF expressed concern that there is not sufficient money in the dock replacement fund and that the Parks and Rec commission did not keep up with contributions to this fund. First Selectman Del Monaco spoke of the possibility of creating a separate account in order to build up this fund. There was a discussion of the total cost of replacement and increase of slip fees and how money will be funded to this separate account. There was a discussion among the members of the BOS regarding getting a written agreement from Parks and Recreation to ensure that the dock replacement fund is kept up in the future.

Pat Del Monaco made a motion to approve the following Inter-Departmental transfer.
