#### **Establishment of School Safety and Security Committee**

Mrs. Del Monaco thanked Anthony Yorio for his leadership and initiative for this committee and noted that the committee will meet on the 2nd and 4th Tuesdays of the month.

Pat Del Monaco made a motion to accept the establishment of the School Safety and Security Committee to review all applicable information and make recommendations to the BOS, BOF and BOE on the necessary measures to improve the safety of children in New Fairfield schools and the security of those schools.
