He noted that the policy for purchasing equipment is that the town pays 85% and the Fire Company pays the remaining 15%. He spoke of the process of purchasing this boat.

Pat Del Monaco made a motion to approve the purchase of a rescue boat to replace Marine 17 for the Ball Pond Volunteer Fire Department using \$21,250 from the Fire Department Reserve Fund. Khris Hall seconded the motion. **Vote: 2-0-0** (Motion approved)
