Correspondence and Announcements

Selectman Kim Hanson noted that Brookfield received some FEMA money from the May 15, 2018 storm and asked about the status of the FEMA reimbursement for New Fairfield. Finance Director Ed Sbordone noted that reimbursements are done by categories and New Fairfield has received some reimbursement. It is unclear when additional reimbursements will be received.

Selectman Khris Hall noted that New Fairfield Fair Day will be held on Saturday, September 7th from noon until 6 pm. This event is run by Parks and Recreation with most events being held on Memorial Field. There will be a Beer/Wine tent this year and there was a brief discussion of the responsibility of insurance for this tent.

NEW BUSINESS

Lake Studies

Khris Hall spoke of approximately \$27,000 in the Capital and Nonrecurring fund for lake studies and surveying and weed mapping. She noted that all three delegates to the Candlewood Lake Authority have recommended having Dr. Greg Bugbee do this survey and weed mapping since he has done this study since 2007. She noted that she has spoke to surrounding towns and they may be willing to join New Fairfield in having this study done.

Khris Hall made a motion to allocate up to \$7,000 to partially fund the proposal by the Connecticut Agricultural Experiment Station to monitor evasive plants in Candlewood Lake and Squantz Pond pending support of surrounding towns. Pat Del Monaco seconded the motion. **Vote: 2-1-0 (Motion approved- Kim Hanson opposed)**

Kim Hanson spoke of this study being redundant and noted that that is has already been done by CLA and Dr. George Knoecklein. He recommended hiring a limnologist if a study really needs to be done. Pat Del Monaco spoke of having consistency with the studies and keeping the same person.

Selectman Kim Hanson asked about the cost of the lake study and the possibility of overpaying for the study.

Carolyn Rowan spoke in support of the Lake Studies test being conducted by Greg Bugbee and her lack of confidence in Dr. George Knoecklein. She further noted that there have been very few weeds this summer in Candlewood Lake.

Kim Hanson also spoke of the condition of the lake for this summer and noted that there is not sufficient evidence as to why there are fewer weeds and milfoil this year.
