224 Route 37, above ground pool, map 13, block 6, lot 11, Kunak. Jeff Kunak, applicant present. Pool was approved in 2002 and permit has expired. Applicant needs to show distance of pool to wetlands. Commission agreed to have application approved administratively. Tom Quigley made a motion to accept application and approve administratively, 2nd by Gerry Schwalbe, all in favor. **Accepted, approval to be done administratively.**

Old Business

49 Knollcrest Rd, Demolish & rebuild single family dwelling with septic, SWMP, remove & replace driveway and patios, new retaining wall, LP tank & generator map 10, block 3, lot 86.4, LF Terrea Phoenix Corp. (D. van der Heyden). Debra van der Heyden present. Construction will be approximately 90' from the lake. Tom Quigley asked for construction fencing to be installed during the demolition of the house. Ms. van der Heyden discussed relocating the septic system away fro the lake and reducing the number of impervious surfaces. Joan Archer made a motion to approve the application, 2nd by Khristine Hall, all in favor. Approved

41 Sail Harbour Dr, clearing saplings trees under 4 inches, remove any invasive plants and repair existing stairway to lake, map 3, block 3, lot 4, Cooper/owner, Manes/agent.
