New Business

41 Sail Harbour Dr, clearing saplings trees under 4 inches, remove any invasive plants and repair existing stairway to lake, map 3, block 3, lot 4, Cooper/owner, Manes/agent. Adam Manes present, representing the owner. The owner want to clear saplings below the pool, from the stone wall down toward the lake. They only plan to remove trees smaller than 4" then plan slow growing grass. Pictures of the area provided and discussed. Owners have met with First Light and filled out out an application with them. Tim Simpkins said he would get a copy of the conservation easement. Tom Quigley made a motion to accept the application, 2nd by Khristine Hall, all in favor. Accepted & Continued

6 East Lane, Single Family Dwelling, Septic, Well, Drive way and Catch Basins, map 10, Block 1, Lot 1, Kraska/owner, Young/agent. Peter Young present, representing the owner. Work proposed is outside the regulated area. They want to fun a drainage pipe to an existing basin that is in the regulated area. Peter said they want to pipe from the ditch to existing basin as discussed while reviewing the plans. The Commission asked Mr. Young to mark the regulated area and the distance of disturbance to the lake on the map. Jennifer Licht made a motion to accept the application for review, 2nd by Gerry Schwalbe, all in favor. Accepted & Continued

Old Business

146 Ball Pond Rd, repair/replace stone seawall & planters, map 34, block 9, lot 2, Ricci. Owner present. Patricia Del Monaco stated that the flowerpots encroach on the pond and should be removed. The seawall appears to be repaired and rebuilt and the Commission questions it was made bigger. The owner said it was done a long time ago and doesn't remember. The owner was instructed to file a new application for the wall. Tim Simpkins will meet with the owner's mason/contractor to agree on the location of where the wall should be rebuilt. The Commission informed the owners that since the wall was rebuilt without a permit, they need to submit an application for the work already done. Tom Quigley made a motion to approve the application with the stipulation that the two planter are removed and the wall discussed rebuilt in it's original location at the shoreline as agreed upon by the EEO.
